## **Neighborhood Christian Legal Clinic Names New Executive Director**

The Neighborhood Christian Legal Clinic's Board of Directors announces Erin L. Hall as the Clinic's new Executive Director. She will step into her role with the Clinic on June 1st. After former Executive Director Amy Adair Horton announced her departure in February, the Board of Directors formed a search committee, assisted by Bryan Orander and Charitable Advisors LLC, tasked with finding the Clinic's next leader. Senior Director of Legal Services Liz Fiscus has served as Interim Executive Director during the transition.

"Erin has a wealth of experience in diverse leadership roles and a passionate desire to serve Christ through the Clinic's mission. We believe that she has a vision and enthusiasm that will serve the organization well," says Russell Brown, Board Chair at Neighborhood Christian Legal Clinic. Erin received her J.D. from Indiana University Robert H. McKinney School of Law, and has served the State of Indiana since 2005, most recently as Director of Policy and Legal Operations with the Indiana Department of Transportation, where she implemented agency-wide policy, managed compliance with state and federal regulations, and oversaw legal operations. She has served as an ADA Indiana Board Member and has served two terms on Indiana's Statewide Independent Living Council.
